- 3) Please note that the financial institution you are transferring from may levy a "transfer fee" on your account. Prompt settlement of this fee will help ensure that there are no delays in the transfer.
- 4) Some Guaranteed Investment Certificates are not transferable until maturity. Please check with the purchasing institution for eligibility.

A note on Transfers

- All the security positions will be transferred from the Delivering Institution "in-kind" (intact) to RBC Direct Investing unless otherwise stipulated.
- While most transfers are processed over a two to four week period, note that depending on the Delivering Institution, time of year, etc., the transfer process can take longer.
